

### **Terms and Conditions**

The Asia-Pacific Regional Space Agency Forum (APRSAF) Poster Contest participants and contributors, including person captured in the digital images such as photograph, and video, hereafter referred “applicants” must read and agree to all of the terms below.

If underaged or who are not able to understand the contents of this document, their guardians must read on behalf of and agrees upon understanding.

### **Privacy Policy**

1. Provided information by POC in countries/regions for the purpose of managing the event, the APRSAF Space Education for All Working Group (SE4AWG), Secretariat, the APRSAF Poster Contest Secretariat and JAXA, hereafter referred “organizers” need to collect applicants personal information and data.
2. Collected personal information will only be used for the operation of the APRSAF Poster Contest, and potential use for public relations of APRSAF SE4AWG and JAXA.
3. The videos and photographs taken in relation to the contest including those provided by the party concerned will be made publicly available.
4. Applicants and their guardians, if applicable, may at any time object to the use of your data for this purpose by writing to the following address: [ap\\_poster\\_edu@ml.jaxa.jp](mailto:ap_poster_edu@ml.jaxa.jp)

### **Intellectual Property**

1. Applicants and, if applicable their guardians, must guarantee that expression and depicted information on the submitted artwork do not violate any legal rights or obligations, such as intellectual property, as applicable. The applicants and, if applicable their guardians will take full responsibility to and to solve any legal issues related to the submitted work.
2. The organizers may use the submitted artwork, results of the competition, and captured personal images for the purpose of public relations and education.

### **Consent content based on EU GDPR**

For the purpose of managing the event, sending of certificates and prizes, ceremony invitations, provide information by and to POC in countries/regions, the organizers need to collect your personal data with the designated formats.

You will find below all the detailed information applicable to this processing of your personal data and a reminder of your rights, in application of the legislation in force.

The organizers willing to respect the privacy and protection of personal data of its prospects and clients, complies with the legislation in force regarding the protection of personal data as data controller, and in

particular Law no. 78-17 of 6 January 1978 (the “Data Protection Act”) and, from 25 May 2018, Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and the free movement of such data (the “GDPR”).

PLEASE BE INFORMED THAT THE PERSONAL DATA WILL BE TRANSFERRED TO THE ABOVE MENTIONED ORGANIZERS, APRSAF SECRETARIAT WEB CONTRACTORS AND POC AND FOR THE PURPOSES AS DESCRIBED ABOVE.

You have, under the conditions defined by the Data Protection Act and the GDPR, unless otherwise provided:

1. The right to withdraw at any time your consent to the processing implemented by the organizing parties based on such consent,
2. The right to obtain from the organizer the confirmation that your personal data are or are not processed and, when they are, access to said personal data as well as to several information on the processing (processing purposes, categories of personal data concerned, recipients or categories of recipients to whom your personal data have been or will be communicated, the retention period of the personal data envisaged or, where this is not possible, the criteria used to determine this duration, etc.),
3. A right of access, rectification and/or erasure of your personal data,
4. The right to receive your personal data provided to the organizers, in a structured, commonly used, and legible format, and the right to transfer this data to another data controller without the organizers having to obstruct it,
5. A right of opposition, for legitimate reasons, to the processing of your personal data and the right of opposition to the use of such personal data,
6. The right to request from the organizers the portability of your personal data in the event you wish to obtain the transfer of your personal data to the benefit of another data controller.

You can set, change and revoke at any time guidelines for the retention, erasure and communication of your personal data after your death. You have the right to appoint a third party to whom your data may be communicated after your death. You agree to inform this third party of your approach.
